General Manager's Report

We are in the process of wrapping up the construction phase of the Well 4 project. At this point Department of Health (DOH) requires us to take a series of samples called a “pilot study,” which tests for inorganic compounds such as Arsenic, Iron and others that could be detrimental to public health. Once we've received the all-clear from DOH, we'll put Well 4 online. This process could take several months to complete, but our aim is to have the new well online and operational no later than the 1st of March.



The generator installation at Well 4 is underway. We have some final tests to run on it over the next few weeks, but expect it to be operational by the middle of January.

We also have some beautification work to do on the area around Well 4. This will be taking place throughout the month of January.

Again thank you for being patient with us on this project. Please don't hesitate to stop by or call us if you have any questions as we wrap up construction of Well 4.

Commissioner's Corner

What Happens When It Rains...

Winter months are quiet times here at the Pointe, but not for the talented and dedicated staff of your water and sewer district. They are working to repair, preserve and upgrade the Pointe's water and sewer systems for our community.



Fewer families are here enjoying the many benefits that make this place the wonderful retreat from the city, and the place we all love. The clear waters of Puget Sound, our pool, the trails and forest get a chance to prepare to again welcome us all back to our own corner of paradise. Summer has turned to winter and our welcome rain is here again. That means trouble for your water and sanitary sewer system. Too much rain water gets into the wastewater pipes, making it impossible to successfully treat the water before discharging the purified wastewater. The problem has a name: Inflow and Infiltration, or simply I&I. Doing all that can be done to correct this is high on our list of priorities.

Inflow and Infiltration (I&I) is groundwater that enters the sewer system through cracks and/or leaks in the sanitary sewer pipes. Cracks or leaks in sewer pipes or manholes may be caused by age-related deterioration, loose joints, poor design, road damage, or root infiltration.

When too much clear water enters a sanitary sewer system, it must be transported and treated like all sanitary waste water. Wet weather magnifies the I&I problem. As rainwater or snowmelt enters the sewer system, it eventually fills the collection and treatment facilities to capacity. Once the sewer system becomes overloaded, water can flow backward, flooding basements or households, or it can overflow the treatment facilities. System overflow happened last winter in Seattle, and a smaller overflow happened here at the Pointe the previous winter. That overflow flooded our facilities and allowed a brief release of untreated wastewater. The Hartstene Pointe Water Sewer District staff will be working throughout the Pointe this winter correcting the I&I challenge. Say hello and thanks when you see them.
