The Importance Fiscal Responsibility

At your water-sewer district, we take fiscal responsibility very seriously. As we have a small staff, we have extra checks and balances—enforced through policies and procedures—to ensure expenditures are scrutinized and funds are appropriately allocated.



December 16th was an interesting morning for our office. We received two emails from the State Auditor's Office (SAO) within two minutes. The first was a press release regarding the recent fraud investigation conducted in Tacoma and the second, an email informing us that our clean, biennial accountability audit report was released.

First, a snippet from the fraud report:

The Office of the Washington State Auditor released its report on a major fraud investigation involving the Pierce County Housing Authority. The finding, nearly \$7 million in misappropriated public funds, is the largest case of its kind on record for a Washington local government.

The State Auditor's Office (SAO) investigation found that the authority's former finance director used a variety of schemes to misappropriate \$6,948,277 in funds since 2016. SAO detected the misappropriation during a routine financial audit, when auditors questioned wire transfers of large sums of money out of state.¹

Contrast that with *our* recent experience with the auditor's office. In October, we welcomed April, a state auditor, into our office to conduct an accountability audit; we are required by law to be audited every two years. She spent two weeks poring over two years worth of meeting minutes, resolutions, contracts, billing, payroll, procedures and policies.

Not only did April's published report contain no findings or management letters (which is great news), but in her presentation to the district's board of commissioners, she made a special point to commend the General Manager David Carnahan, Projects & Accounts Manager Joe Sartori, and previous Accounting & Administrative Services Manager Miceal Carnahan (now a consultant) for their work.

Per district policy, invoices are compiled and prepared for payment by the District Clerk, each invoice is approved by the General Manager for submittal to the board of commissioners and audited by the internally-designated Audit Commissioner, then submitted to the board of commissioners for authorization. This is an example of a procedure that the auditor reviewed and considered robust and in good practice.

We are proud that our community can be confident knowing that the funds entrusted to us are wisely and transparently managed, safe-guarded from misappropriation and ultimately invested in supporting our infrastructure to serve the entire Pointe.
